- A fee (as per standard tariff) shall be charged per presentation by the LC issuing bank (Mizuho Bank, Ltd) if Documents containing
  discrepancies are presented for payment/reimbursement under this Letter of Credit. This fee will be charged for each presentation and
  will be payable by the Beneficiary even when terms indicate that some or all charges are on account of Applicant.
- Mizuho Bank, Ltd, complies with the International Sanction Laws and Regulations issued by the United States of America, the European
  Union, the United Nations, Japan and other authorities as the case may be. In the event that the underlying transaction/ trade/
  document(s) involves a Sanctioned Country or a Blocked Person (Individual/ Entity/ Jurisdiction/ Country of Origin/ Port of Shipment/
  Port of Destination/ Port of Transhipment/ Intermediary Port/ Vessel/ Property; etc); Mizuho Bank, Ltd shall not perform any obligation
  under this Letter of Credit. This Clause shall apply notwithstanding any inconsistency with the current edition of the International
  Chambers of Commerce- Uniform Customs and Practice for Documentary Credit (ICC- UCPDC).

- I/We further declare that the undersigned has/have the authority to give this Declaration cum Undertaking on behalf of the Applicant (Firm/ Company).
- We declare and confirm that Insurance will be covered for the goods being imported from Beneficiary's warehouse to Applicant's warehouse for minimum 110% of invoice value (Applicable when Insurance is covered by the Applicant).
- We confirm that we shall provide funds in our Account for settlement of Documents within 5 days from receipt of documents at your counter for Sight Bills and on or before the Due Date in case of Usance Bill(s) as per FEDAI guidelines.
- In consideration of your granting us the above request, we hereby agree to perform our obligations and/or liabilities in connection with this Letter of Credit as per conditions set-forth in the Application as well as Facility Agreement for Letter of Credit transactions executed by us.
- Except as otherwise expressly stated in this Application, this Letter of Credit is subject to Uniform Customs and Practice for Documentary
  Credit (2007 Revisions) of International Chambers of Commerce Publications No- 600 read with ICC Publication No- URR 725 and ISBP
  Latest Version.
