Subject to the following conditions :</p> <p>It is agreed and understood that in receiving the items described herein, Mizuho Bank, Ltd. hereafter called "the Bank" and its correspondents and their agents or sub-agents shall act as your agents and that the Bank assumes no responsibility except for the exercise of ordinary care in the selection of its immediate correspondents for presentation or collection of the item.</p> <p>The Bank and its correspondents may forward any item by mail or otherwise, directly or indirectly, to any bank, including the drawee or payer thereof. The Bank shall not be liable for failure to collect, loss of exchange, loss of interest or any other loss or damage due to any of the following events :</p> <p>default, neglect, error, omission, suspension or insolvency of any correspondent or sub-agent thereof; delay in presentation or collection; delay or loss in transmission or delay in arrival of drafts, documents or proceeds thereof or of the underlying goods, or delay in giving notice thereof to you, mutilation, error, omission or delay in transmission or delivery of any telegram, letter, cable or other written or oral communication; declared or undeclared war; censorship, blockade, insurrection, civil commotion, breakdown or interruption of communication or because of any law, decree, regulation, control or act of public authority of a domestic or foreign government de jure or de facto or any agency thereof, whether rightfully or wrongfully exercised or any act beyond the Bank's control.</p> <p>If the Bank at any time shall negotiate, make any advances against or discount any of the drafts described herein, it shall have all the rights and remedies in the Bank's letter of hypothecation and general assurance, the terms of which shall be controlling if there be any inconsistency between the terms thereof and the instructions appearing herein.</p> <p>The Bank may, at its option, instruct its correspondents to advise it by cable at your expense, of non-acceptance and/or nonpayment, as well as payment of any items discounted, negotiated by the Bank or against which the Bank made in advance.</p> <p>The instructions to collecting agent appearing herein shall be deemed to have been approved by you and to be your instruction unless you immediately request the Bank in writing to change such instructions or any of them.</p>
