Change of the Trade Name of the European Subsidiary
Upgrading of the Madrid Representative Office to the Branch Status

Mizuho Bank Nederland N.V., a 100% subsidiary of Mizuho Bank, Ltd. (President & CEO: Nobuhide Hayashi, hereinafter “MHBK”), has changed its trade name to Mizuho Bank Europe N.V., effective from January 1, 2017. At the same time, its Madrid Representative Office (RO) has been upgraded to the Madrid Branch.

The history of Mizuho Bank Europe N.V. dates back to March 1974, when Mizuho Bank Nederland N.V. was opened in Amsterdam (the Netherlands). Its business network has now extended to cover 21 countries in Europe, with the Brussels Branch (Belgium), the Madrid RO (Spain), and the Vienna Branch (Austria) opened in July 2006, September 2008, and July 2015, respectively. The change of the trade name reflects its role as a European subsidiary responsible for a number of countries across Europe.

Spain is the fifth largest economy in Europe and a popular tourist destination. It also serves as a gateway to the Latin American markets due to the language and cultural affinities, including business practices.

Mizuho has previously supported customers with business needs in the Iberian Peninsula through the Madrid RO. Its upgrading to the branch status will further enhance our business framework in the region and accelerate the development of the network across Europe.

Through the network of MHBK branches and Mizuho Bank Europe branches, Mizuho will provide enhanced support to customers in the markets they are expanding their business.
