Please be informed that in making such disclosure of your customer information and/or company information, the Bank is subject to applicable laws and regulations including the Banking Act 1970 of Singapore and the Notice, and the Bank intends to take all reasonable efforts so that such disclosure is in compliance with such applicable laws and regulations.
- 4. This letter takes effect on 11 December 2024 (the "Effective Date").
- 5. Your continued use of the Products and Services from the Effective Date is subject to the contents of this letter and will be deemed to constitute your acknowledgement and agreement to the contents of this letter. From the Effective Date, this letter will be considered to be part of any agreement(s) and/or document(s) that you have entered and/or will enter into with the Bank or any arrangement that you have/will have with the Bank in connection with the Products and Services.
