Line 2: Deficitedary Name

Line 3: Beneficiary Address, include

Line 4: City and Country locations

2. Beneficiary Account No [SWIFT Field 59 < Account>]

For payment to European Bank, provide IBAN Code.

3. Beneficiary Bank SWIFT BIC, Name & Address [SWIFT Field 57A – 4 lines*35x]

Provide full 11 characters Beneficiary Bank's SWIFT BIC and the Beneficiary Bank Name and Address.

4. Other Information [SWIFT Field 70]

Provide the Beneficiary with information such as Payment Information, Invoice Details, etc.

5. Bank Charges [SWIFT Field 71A < Detail of Charges>]

For drawback currency remittance, Mizuho does not accept 'BEN' option. Choose "SHA" or "OUR".
